HOW PRC AND MHC TAX CREDITS WORK:

- Donate \$100 or more to MBCH-CFM or The LIGHT House
- 2 Contact your Regional Representaitve so MBCH can send you a tax credit application
- Return the completed form to MBCH
- 4 MBCH will process and submit the application to the State on your behalf
- 5 The State will send you paperwork for your taxes (45-90 days)

WHY DO YOU WANT A TAX CREDIT?

A tax credit is not the same as a deduction. Deductions reduce your taxable income while tax credits directly reduce the amount of tax you owe. In fact, 70% of your eligible donation to MBCH (up to \$50,000 in PRC and \$50,000 in MHC per year) may qualify for a tax credit for your business or individual Missouri tax return.
